**Re: Prioritizing SSI/SSP In the 2017-18 Budget**

Dear Governor Brown, Senator Mitchell and Assemblymember Ting,

Californians for SSI (CA4SSI) represents more than 200 organizations that represent the more than 1.3 million Californians who rely on the combined federal/state Supplemental Security Income/State Supplemental Payment program and have experienced cuts with devastating costs to themselves and to our state. We write to you regarding the need to prioritize investments in SSI/SSP in the 2017-18 budget.

**SSI/SSP Grants & Cost of Living Adjustment**

The state contributions to the SSP grant for individuals have been cut from \$233 a month to the federal minimum of \$160 a month, a \$77 monthly reduction per person since 2007. The state contribution for a couple in January 2007 was \$568 a month but has been reduced to \$407, a \$168.80 a month cut. SSI grants for couples are lower now than they were in 2007.

In the 2007-8 budget, the state spent \$3.6 billion on the state portion of the SSI grant. In the proposed budget the Administration will spend \$2.9 billion yet the SSI caseload climbed by around 75,000 persons after 2007. That is a cut of \$700 million - all absorbed by persons with no other way of paying for the essentials of life.

While the Legislature has restored funding for K-12 education, the Judiciary, the state college system, IHSS, Medi-Cal and even some restorations for CalWORKs very few of the funds cut from SSI recipients has been restored. We thank the Administration and Legislature for the first

[post-Recession restoration in the \\$73.2M 2016-17 COLA](#), though that is a one-time investment. that represents “the smallest theoretical increase that can be provided” to SSI/SSP recipients.<sup>1</sup>

**CA4SSI supports restoring all the cuts and cost of living adjustments that have been denied until the grants for individuals and couples are above the federal Supplemental Poverty Measure that accounts for California’s extraordinary costs of living.**

The 2016-17 budget included \$45 million for the Housing & Disability Advocacy Program, part of the Senate Pro Tem’s No Place Like Home Initiative, though this was cut in the 2017-18 January 10 proposal. HDAP would have created a fund of state dollars available for county matching funds. Based on highly successful models, HDAP programs would temporarily house and stabilize SSI applicants to reduce homelessness among this extremely vulnerable population and assist them in the extremely long application process that typically lasts 18-24 months.

**CA4SSI asks the Administration & Legislature to fully implement the HDAP program in the 2016-17 budget year.**

CA4SSI looks forward to working with the budget committees and the Administration to help every Californian move out of poverty and live with dignity.
