- Right to accommodations for the disabled
- Right to ask for help with completing the application
- · Right to forms in your primary language
- Right to a county paid interpreter
- Right to expedited service if eligible
- Right to be promptly interviewed within 7 working days
- Right to see you case
- Rights to get any document from your case free
- of charge if you want to ask for a state hearing • Right to a State Hearing

- What issues are covered in SH
- · What issued are not covered- ADA, worker treatment, etc.

What to Put on the Request

"County action is wrong"

Aid Paid Pending

- Filing a request before the effective date of the NOA
- APP is due within five (5) working days
- APP Appeals to DSS
- No APP for recertification

Adequate NOA

- What is an adequate NOA
- Language issues
- Notice at Issue

What Happens At the Hearing

- Hearing is tape recorded
- ALJ explains the hearing process
- CWD and claimant and witnesses take the oath
- Who can come to the hearing
- County goes first
- Claimant can cross examine the county
- Claimant presents case
- CWD can cross examine the claimant
- Leaving the record open

Interpreters

- State provides interpreters
- You must identify the language when asking for the hearing
- ALJ is suppose to examine the interpreter

Postponements & Continuances

- First postponement requires no verification
- Second time must have doctor verification
- Position Statement not available timely
- Time Waivers King and Ball

No Shows

- If the claimant does not appear at the hearing but asks to reopen the hearing with good cause within 10 days, then APP will be restored
- A rehearing is routinely granted for hearing dismissed.

Hearing Decision timelines • Food Stamp issues-60 days

Hearing Record

- You can request a copy of the hearing tapes It is free
- If you file for judicial review you must request a transcript

- History
- Who may ask for an ESH
- How to ask for the hearing

- Hearing to be held within 5 days
- Decision in 10 days
