# **Sponsor FAQ**

## What kind of signage is allowed?

CAFB is happy to work with both Premier and Featured-level sponsors to place their banners or pop-up signs near the podium so they can be seen throughout the day. Lunch and Breakfast-level sponsors will have their company logo projected on either side of the podium while attendees are dining. Break sponsors will have smaller, printed signs accompanying the refreshments provided in the main walkway during breaks.

## What does priority seating entail?

Should a Lunch, Breakfast, or Reception sponsor wish to meet or build a relationship with a particular attendee, CAFB will ensure that up to four guests are seated with the attendee during the sponsored event. Otherwise, up to four guests of the sponsor will be seated with a selected group of prominent food bank members.

## What does being an exhibitor entail?

Exhibitor tables are for educational and informational purposes only. You may not conduct retail sales on the exhibit floor during the conference. California Association of Food Banks reserves the right to prohibit any display or exhibit or any part of a proposed exhibit which it judges not suitable or in accordance with acceptable professional ethics of CAFB. Exhibitor space will be in the main walkway and gathering area. Each exhibitor space will be provided with an 8' x 3.5' table, two chairs, and an ID sign. Exhibitors are welcome to use this sign or opt to bring their own drape or display provided it fits behind the table.

Please note that the "Exhibitor Only" option includes one attendee. For each additional attendee, please include \$125 per person in your payment.

## Are there any additional benefits to sponsorship?

All sponsorship levels include meals, the option to include promotional materials in attendee tote bags, registration to all conference sessions, and tickets to CAFB's member reception on the evening of May 4.
