



Pandemic EBT 3.0: Outcomes Report

Pandemic EBT 3.0

Pandemic EBT (P-EBT) 3.0 was a disaster response program intended to support school-aged children and young children under age six who lost access to free or reduced-price school meals due to facility closures; students transitioning to a virtual learning model, such as independent study; due to COVID-19 concerns, or absences from school due to COVID-19 illness during the months of August 2021 through May 2022. P-EBT 3.0 also authorized summer benefits for eligible children for June 2022 through August 2022.

P-EBT 3.0 was administered by the California Department of Social Services (CDSS) in partnership with the California Department of Education (CDE).
