

# The Summer Food **Program for Kids!**

SUN Bucks is a new food program that gives families \$120 per eligible child to buy groceries during the summer. Children who get SUN Bucks can still receive other food programs like CalFresh and meals at Summer Meal Sites. SUN Bucks is for all eligible children, and will NOT affect immigration status.

### **CAN MY CHILD GET SUN BUCKS?**

#### Your child will automatically get SUN Bucks if:

- Your child got CalFresh or CalWORKS at any point during the 2024-25 school year.
- Your child got Medi-Cal at any point during the 2024-25 school year & your family meets the income guidelines below.
- Your child is experiencing homelessness, living in foster care, or is in a migrant family.
- You applied for your child to receive federal Free or Reduced-Price Meals & were approved for the 2024-25 school year.



Make sure your mailing address is updated with your county so your SUN Bucks are sent to the right place!

#### Your child will need to apply for SUN Bucks if:

• Your child attends a Community Eligibility Provision (CEP) or Provision 2 school or a National School Lunch Program/ School Breakfast Program school AND has NOT completed a free or reduced price school meal application AND doesn't meet the criteria above.



Submit a "Universal Benefits Application" form by September 2, 2025. Ask your school for information about where to get the form and how to submit it.

## **HOW DO SUN BUCKS WORK?**

- · You will get one new SUN Bucks card for each eligible child mailed to your home or designated mailing address.
- · Cards for automatically enrolled children will be mailed between June and August. Cards for eligible children who applied for SUN Bucks will start mailing in September.
- You can PIN your card by contacting the helpline or using the ebtEDGE app.
- The SUN Bucks card will work like a debit card. You can use SUN Bucks to buy food (except prepared/hot foods) at grocery stores, farmers markets, and other stores that accept CalFresh benefits.
- SUN Bucks must be used within 122 days of the date when benefits were loaded.
